



How to use the BoardDocs eGovernance System

Beginning March 11, 2008, San Diego Unified implemented the BoardDocs eGovernance system. The system makes board reports available on the Internet, cuts down on printing costs, and distributes board documents quicker and more efficiently.

1 To access Board meeting exhibits, go to the [Board of Education page](#). Click on the Reports link next to a meeting date. For meetings held on and after March 11, follow the BoardDocs eGovernance instructions below.

2 To view the Exhibits, click on the Enter Public Site button.

3 The SDUSD eGovernance homepage will appear.

4 To view the Exhibits for a particular board meeting, click on the plus sign (+) next to the meeting date on the left side of the screen.

The Board begins their meeting in closed session at 12:00 p.m. in Room 2249 and the open (public) session begins at 3:00 p.m. in the Eugene Brucker Education Center Auditorium located at 4100 Normal Street, San Diego, CA.

Public Testimony - Members of the public wishing to provide the Board public testimony on items not listed on the agenda must either call the Office of the Superintendent, Board Services Office at 619.725.5634 by 5:00 p.m. the day preceding the Board meeting or submit a "Public Testimony Request Form" to the Board Action Officer prior to the beginning of "Public Testimony." Hearings are limited to a maximum of fifteen minutes per subject with a maximum of three minutes per speaker. No deferral of time is allowed.

Public Testimony on agenda items - Speakers will be called on to speak during the discussion of the agenda item. Hearings are limited to a maximum of three minutes per speaker. No deferral of time is allowed.
