## **PARENT INVOLVEMENT POLICY STATEMENT**

The Board of Education recognizes the necessity and value of parent involvement to support student success and academic achievement. In order to assure collaborative partnerships among schools, parents, and the community, the board, working through the administration, is committed to:

- a. involving parents as partners in school governance including shared decision making.
- b. establishing effective two-way communication with all parents, respecting the diversity and differing needs of families.
- c. developing strategies and programmatic structures at schools to empower parents to participate actively in their children's education.
- d. providing support and coordination for school staff and parents to implement and sustain meaningful parent involvement from kindergarten through grade twelve.
- e. utilizing schools to connect students and families with community resources that provide educational enrichment and support.

## **NORMAS QUE RIGEN EL PROGRAMA DE PARTICIPACION DE PADRES**

La Mesa Directiva reconoce la necesidad y el valor de la participación familiar para servir de apoyo y ayudar a lograr el éxito del alumno y su aprovechamiento académico. Para asegurar la mejor alianza colaborativa, entre la escuela y los padres de familia, la mesa directiva, por conducto de la administración escolar, se compromete a:

- a. incluir a los padres de familia como socios en los comités de la escuela incluso en la toma de decisiones colaborativas.
- b. establecer una comunicación efectiva con los padres de familia, con respeto a la diversidad y las distintas necesidades de cada familia.
- c. desarrollar estrategias y programas estructurados en las escuelas para facilitar que los padres de familia participen de una manera activa en la educación de sus hijos.
- d. proporcionar el apoyo y la coordinación al personal docente y a los padres de familia para poder llevar a cabo y continuar eficazmente la participación familiar desde el kinder hasta el grado doce.
- e. utilizar a las escuelas para unir a los alumnos y a los padres de familia con los recursos de la comunidad que proporcionan enriquecimiento y apoyo educativo.
